#### REPRESENTATIVE CASES

Over the years FHM has handled many maritime criminal cases. The following are but a few representative samples.

• M/V NEW CARISSA – 1999 – This grounding and total loss of a vessel on the Oregon coast resulted in major pollution and natural resource damages. FHM defended the shipowner/operator in a criminal Grand Jury investigation by U.S. Attorney in Oregon for Clean Water Act violations.

**Result:** The government was persuaded not to prosecute criminal charges against owner and operator.

• Defense of Shipowner – 2004 – FHM defended a shipowner/operator in a U.S. Grand Jury investigation in New Jersey for a possible OWS violation.

Result: We were successful in blocking the government from filing any criminal charges.

• Defense of East Coast Tug Operator – 2005 – We represented a New York tug operator in the U.S. government's investigation of major oil spill from a barge in Long Island Sound, which resulted in significant pollution of Long Island beaches. FHM defended the tug owner/operator in respect of Clean Water Act criminal investigations.

Result: Persuaded authorities not to bring any criminal charges.

• OWS Defense – 2009 – We were called in to represent Spanish owner/operator in a pending criminal case brought by U.S. Attorney in Boston charging violations of the Act to Prevent Pollution for Ship and obstruction of justice. The government was demanding a \$10 million dollar fine to settle the case.

Result: We objected to the fine as excessive and after several meetings with the U.S. Attorney and high level individuals from the DOJ in Washington, the fine was settled for \$2 million dollars to be paid in installments. This was the first such case in the U.S. where a shipowner was permitted to pay a fine in installments over a period of five years rather than all at once on the date of settlement. Also, on our motion, the Court reduced the probation period of the Court mandated Environmental Compliance Program from 5 years to 2 years, thereby permitting our client to do business with oil majors.

• Defense of Greek Shipowner – 2011 – An OWS violation prosecuted by the U.S. Attorney in San Francisco.

**Result:** We investigated the incident and then negotiated a \$500,000 fine, which was the lowest fine leveled against a shipowner for an OWS violation in recent years. Most settlements of these types of cases in the U.S. result in multi-million dollar fines.
